- + **Intake:** Subject to minimum class size enrolled.

- + **Fees to be paid upon registration:**
  - Foreigners & Local: Full Fees + GST
- + **Applicants to submit the following documents for registration:**
  - a) Applicant Company's Business Profile printed within 6 months of application date (available from ACRA's QuesNet Online Portal)
  - b) Photocopy of participant identification (NRIC for Local and Work Permit/Employment Pass for Foreigner – front & back)
  - c) Employment records printed via 'Work Permit Online' at MOM's website (for foreign participant only)
  - d) CoreTrade Acknowledge Notice
- + **Replacement and Withdrawal**  
50% refund on full course fee will be made if the notice of withdrawal is received by Positive Engineering Pte Ltd at least 2 weeks before the course commencement date. If such notice is received by Positive Engineering Pte Ltd less than 2 weeks but more than 4 working days before the course commencement date, 25% refund on full course fee will be made. No refund will be given if Positive Engineering Pte Ltd received the notice of withdrawal 4 working days or less before the course commencement date. An administration fees of \$100 is chargeable for the replacement of participants and the substitute meets all the entry requirements and the request is made at least 4 working days before the commencement of the course.
- + **Deferment**  
An administration fees of 25% of the full course fee is chargeable if notice in writing is received by Positive Engineering Pte Ltd at least 2 weeks before the course commencement date. An administration fee of 50% of the full course is chargeable if the notice is received by Positive Engineering Pte Ltd less than 2 weeks but more than 4 working days before the course commencement date. No deferment is allowed if Positive Engineering Pte Ltd received the notice 4 working days or less before the commencement date of the course.
